RULES AND REGULATIONS

THE FOLLOWING RULES AND REGULATIONS are a part of the Sandy River Equestrian Center (SREC) agreement signed by riders, boarders, and any other individuals using the facility. All other individuals visiting the center for any reason shall abide by the same rules and regulations.

- **HOURS:** Open seven days a week from 8:00 a.m. to 10:00 p.m. except on special occasions designated by the owner. All horses should be ridden, groomed, and put in a stall or out to pasture by 10:00 p.m.
- **VISITORS:** All visitors must obtain permission in writing from the owner/manager and sign a liability release form to ride any horse at SREC.
- **NON-BOARDERS:** Must obtain permission to ride his/her horse anywhere on SREC property from the owner/manager and sign a liability release form. Horse owner must have a copy of the current negative Coggins.
- **CHILDREN:** Children under 14 years old are NOT permitted in the barn unless accompanied by a parent or adult. NO child may ride alone.
- **JUMPING:** **Under NO circumstances** should anyone jump without an Instructor that has been recognized and approved by Suzanne Lacy or Sam Henley present in the ring, on trails, or on the cross country courses.
- **SCHOOL HORSE USE:** No school horses shall be ridden outside lessons without permission from Suzanne Lacy or Samantha Henley nor should anyone give lessons without their knowledge
- **HELMETS AND PROTECTIVE VESTS:** Helmets MUST be worn at all times when rider is mounted. Protective vests are required when cross-country jumping.
- **INDOOR SAFETY:** NEVER ride a horse inside the barn area. All horses must walk to their paddocks, to individual stalls and to and from the indoor arena. NO grooming in barn aisles. Please use your stall or the wash stalls.
- **CLEANLINESS:** Riding arenas, stall areas, and grooming areas are to be kept clean and picked up at all times after you have used them.
- **LOUNGE AND RESTROOM:** These rooms are provided for your convenience, so PLEASE pick up after yourself and your children. Keep these rooms clean by wiping up any mess you have made. In the winter keep doors closed to conserve heat.
- **TRASH:** Containers are located throughout the barn and outside on the east side of the main barn, please use them!
- **TELEPHONE:** Use for brief local calls only. This is a business phone.
- **TACK ROOM:** Provided for horse boarders and students of SREC only.
- **ALCOHOL, DRUGS, SMOKING, MISCONDUCT:** Will NOT be allowed in the barn or on the premises. On rare occasions, alcoholic beverages may be acceptable for special events, but only under the permission of the owner.
- **DOGS:** NO dogs are allowed in the barn, on trails, or near the riding areas. SREC has had to make this decision because dogs often spook horses which can result in serious injury. You may keep a dog in your car if you must bring it with you to the barn.
